INVITATION FOR EXPRESSION OF INTEREST TENDER NO. ZRL/TEN/MPS/0012/2018 THE DEVELOPMENT OF INTER-MODAL DRY PORTS

- 1. This Expression of Interest for the development of Dry Ports follows the desire by Zambia Railways Limited (ZRL) to utilize its asset of land available at some of its major stations along the line of rail, with the intention of speeding up inter-modal cargo handling activities along the line of rail.
- 2. The Dry Ports are supposed to be sources of cargo to ZRL. At the same time these will be loading and offloading points complete with warehousing and consolidation, weigh bridges, 3rd party logistics providers, customs facilities, freight forwarders, distribution center services etc.
- 3. ZRL has identified some sizeable land for the development of at the following seven (7) sites/locations:

1	Livingstone	South end of Livingstone yard near the locomotive sheds
2	Lusaka	Lusaka goods shed
3	Ndola	Ndola goods shed
4	Kitwe	Behind Kitwe loco sheds/ adjacent to former Kitwe goods shed
5	Chambishi	Chambishi yard
6	Chingola	Chingola goods shed and yard
7	Chililabombwe	Chililabombwe goods shed and yard

- 4. ZRL now invites Expressions of Interest from interested firms or consortiums for the development of Dry Ports at the above stated locations. The Expressions of Interest must provide the following information: Information on the firm(s) and its representatives (if any), the Name, Nationality, Address, Telex/Telephone and Facsimile/ E-mail; Indicate under which name (s) and for how long the company has been providing similar services/works; The firm's General Organizational Chart to execute the appraisal, design, construction, commissioning and operation phases, the Name, Position and Curriculum Vitae of key personnel; information on the experience of the firm(s) in the development of similar projects over the last ten years with the following details:
 - A detailed Company profile;
 - Certificate of incorporation;
 - Valid Tax Clearance for year 2018;
 - CVs of key personnel to be deployed on the project;

- Past performance record of similar projects; and
- Audited financial statements for the last three (3) years.
- 5. If two or more firms associate themselves, each one must include their own information documentation as stipulated above in the consortium submission. Interested firms are advised to provide any other additional information. All the information provided must be in English.
- 6. Five (5) copies of Expression of Interest including the original should be clearly marked "TENDER NO. ZRL/TEN/MPS/0012/2018 EXPRESSION OF INTEREST FOR THE DEVELOPMENT OF DRY PORTS" and addressed to the Manager Procurement, Zambia Railways Limited, Top Office, Corner of Ghana and Buntungwa Avenue, P.O. Box 80935, Kabwe, Zambia, and must be received not later than Friday April 20, 2018 at 10:00 hours local time.
- 7. Appropriately bound and sealed proposals must be deposited in the Tender Box situated at Zambia Railways Limited, Top Office, Corner of Ghana and Buntungwa Avenue, Kabwe, Zambia, on or before **Friday 20**th **April, 2018** *at 10:00 hour's local time*.
- 8. The closing date for receipt of proposals is **Friday 20th April, 2018** at 10:00 hour's local time and any proposals received after the time and date stipulated above will not be accepted. The proposals will be opened soon after closing in the Board room, at Top Office, Corner of Ghana and Buntungwa Avenue in the presence of the bidders or their representative who may choose to attend.
